4.1 Description of necessary first-aid measures

If inhaled

SECTION 12: Ecological information

12.1 Toxicity

- Toxicity to fish: LC50 *Pimephales promelas* (fathead minnow) 726 mg/l/96 hr (confidence limit 673 - 783 mg/l), flow-through bioassay with measured concentrations, 25.0 deg C, dissolved oxygen 5.7 mg/l, hardness 45.0 mg/l CaCO₃, alkalinity 51.3 mg/l CaCO₃, and pH 7.58.
- Toxicity to daphnia and other aquatic invertebrates: no data available

12.2 Persistence and degradability

ANAEROBIC: The maximum pseudo-first-order rate constant and half-life for 2-pyridinecarbonitrile in an anoxic sediment slurry from the estuary of the Tansui River (Guandu, Taipei) were 1.01 per day and 16.5 hrs, respectively(1). 2-Pyridinecarbonitrile was not transformed in the sterile control sediment slurry(1) which suggests that 2-pyridinecarbonitrile may degrade in the environment, at least under anaerobic conditions(SRC).

12.3 Bioaccumulative potential

An estimated BCF of 3 was calculated for 2-pyridinecarbonitrile(SRC), using a log K_{ow} of 0.45(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

12.4 Mobility in soil

The K_{oc} of 2-pyridinecarbonitrile is estimated as 42(SRC), using a measured log K_{ow} of 0.45(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated K_{oc} value suggests that 2-pyridinecarbonitrile is expected to have very high mobility in soil(SRC).

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
