## SECTION 4: First-aid measures

### 4.1 Description of necessary first-aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

### 4.2 Most important symptoms/effects, acute and delayed

Inhalation causes mild irritation of mucous membranes. Ingestion of liquid or contact with skin or eyes causes mild irritation. (USCG, 1999)

### 4.3 Indication of immediate medical attention and special treatment needed, if necessary

## SECTION 5: Fire-fighting measures

### 5.1 Suitable extinguishing media

If material on fire or involved in fire: Do not extinguish fire unless flow can be stopped or safely confined. Use water in flooding quantities as fog. Solid streams of water may spread fire. Cool all affected containers with flooding quantities of water. Apply water from as far a distance as possible. Use foam, dry chemical, or carbon dioxide. Chloropentanes

### 5.2 Specific hazards arising from the chemical

Special Hazards of Combustion Products: Irritating hydrogen chloride and toxic phosgene may be formed in fires. (USCG, 1999)

### 5.3 Special protective actions for fire-fighters

Wear self-contained breathing apparatus for firefighting if necessary.

## SECTION 6: Accidental release measures

### 6.1 Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

## 6.2 Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

## 6.3 Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

## SECTION 12: Ecological information

### 12.1 Toxicity

### 12.2 Persistence and degradability

Aerobic cultures containing 1-chloropentane inoculated with sewage from three different treatment plants, reached 1.5, 1.8, and 2.8% of the theoretical oxygen demand in 6, 12, and 24 hours, respectively(1). Pure cultures of *Corynebacterium* sp., *Acinetobacter* sp., *Arthrobacter* sp.(2), and *Alcaligenes faecalis*(3) have been shown to degrade 1-chloropentane.

### 12.3 Bioaccumulative potential

An estimated BCF value of 32 was calculated for 1-chloropentane(SRC), using a measured water solubility of 197 mg/l(1) and a recommended regression-derived equation(2). According to a classification scheme(3), this BCF value suggests that bioconcentration in aquatic organisms is moderate, not high(SRC).

### 12.4 Mobility in soil

The Koc of 1-chloropentane is estimated as approximately 240(SRC), using a measured water solubility of 197 mg/l(1) and a regression-derived equation(2,SRC). According to a recommended classification scheme(3), this estimated Koc value suggests that 1-chloropentane has moderate mobility in soil(SRC).

### 13.1 Disposal methods

#### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
