If inhaled

6.1 Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

An estimated BCF value of 290,000 was calculated for oil pink(SRC), using a measured log Kow of 7.5(1) and a recommended regression-derived equation(2). According to a recommended classification scheme(3), this BCF value indicates that bioconcentration in aquatic organisms will be an important fate process(SRC).

12.4 Mobility in soil

The Koc of oil pink is estimated as approximately 290,000(SRC), using a measured log Kow of 7.5(1) and a regression-derived equation(2,SRC). According to a recommended classification scheme(3), this estimated Koc value indicates that oil pink will be immobile in soil(SRC).

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
