SECTION 4: First-aid measures

4.1 Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

4.3 Indication of immediate medical attention and special treatment needed, if necessary

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. Poisons A and B

6.1 Personal precautions, protective equipment and emergency procedures

12.2 Persistence and degradability

AEROBIC: Complete recovery of cotinine as $^{14}\text{CO}_2$ (N-methyl-labeled) was observed after 72 days incubation using sediment samples collected upstream and downstream from a municipal wastewater treatment plant outfall on Fourmile Creek near Ankeny, IA(1). However, caffeine exposure was shown to decrease cotinine biodegradation by 36 and 200% using sediments from Boulder Creek and the Platte River, respectively. Biodegradation proceeded via microbial demethylation of the N-methyl component of cotinine and is metabolic precursor, nicotine(1).

12.3 Bioaccumulative potential

An estimated BCF of 3 was calculated in fish for cotinine(SRC), using a log Kow of 0.07(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

12.4 Mobility in soil

The Koc of cotinine is estimated as 130(SRC), using a log Kow of 0.07(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that cotinine is expected to have high mobility in soil. Using a 2.4 m soil column packed with Mohall-Laveen sandy loam soil from an area northeast of Phoenix, AZ and a secondarily-treated effluent from a municipal waste treatment plant, cotinine concentrations were reported as 0.137 and below the reporting limit of 0.023 ug/L at the beginning and ending dates of May 29, 2001 and Jun 6, 2001, respectively. The concentration in the soil column drainage basin was 0.101 ug/L, collected on Jun 20, 2001(4).

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
