SECTION 4: First-aid measures

4.1 Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

4.3 Indication of immediate medical attention and special treatment needed, if necessary

Basic treatment: Establish a patent airway (oropharyngeal or nasopharyngeal airway, if needed). Suction if necessary. Watch for signs of respiratory insufficiency and assist ventilations if necessary. Administer oxygen by nonrebreather mask at 10 to 15 L/min. Anticipate seizures, minimize external stimuli, and treat if necessary. For eye contamination, flush eyes immediately with water. Irrigate each eye continuously with 0.9% saline (NS) during transport. Do not use emetics. For ingestion, rinse mouth and administer 5 ml/kg up to 200 ml of water for dilution if the patient can swallow, has a strong gag reflex, and does not drool. Administer activated charcoal. Chlordane and related compounds

SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

6.2 Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

SECTION 12: Ecological information

12.1 Toxicity

12.2 Persistence and degradability

AEROBIC: Dechlorane plus, present at 100 mg/l, reached 0.6% of its theoretical BOD in 2 weeks using an activated sludge inoculum at 30 mg/l and the Japanese MITI test(1). Nominal dechlorane plus concentrations of 0.01, 1, 10 and 100 mg/l in water inoculated with sewage sludge remained unchanged after 21 days(2). C-14 labeled dechlorane plus was not degraded within 2 weeks in an aerobic biodegradation test using a sewage sludge inoculum(2). Some degradation was reported after 6 weeks. The concentration of the test substance was not specified. No oxygen utilization was detected after 21 days during a closed bottle test using a sewage sludge inoculum(2). The initial concentration of dechlorane plus was 4 mg/l. Based on these screening test results, biodegradation of dechlorane plus is expected to be very slow in the environment.

12.3 Bioaccumulative potential

A BCF range of 14-121 was measured using orange-red killifish (*Oryzias latipes*) which were exposed over an 8-week period(1). According to a classification scheme(2), this BCF range suggests the potential for bioconcentration in aquatic organisms is low to high(SRC), provided the compound is not metabolized by the organism(SRC). The concentration of dechlorane plus measured in archived fish (walleye) from Lake Erie was 0.14-0.91 ng/g lipid weight indicating that this substance is at least partially biologically available(3).

12.4 Mobility in soil

The Koc of dechlorane plus is estimated as 4.9×10^7 (SRC), using a water solubility of 4.4×10^{-8} mg/l(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that dechlorane plus is expected to be immobile in soil.

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
