If inhaled

Fresh air, rest.

SYMPTOMS: Symptoms of exposure to this compound may include skin irritation and sensitization, and redness of the skin.

ACUTE/CHRONIC HAZARDS: This compound causes irritation on contact. When heated to decomposition it emits acrid smoke and fumes. (NTP, 1992)
