4.1 Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Absorption, Distribution and Excretion

When 6-tert-butyl-m-cresol was allowed to interact with bovine serum albumin, the numbers of sites occupied/molecule of protein was 17. the number of sites occupied was a linear function of the distribution coefficient for partition between hydrated silica & the organic mobile phase in thin-layer chromatography & a linear function of the differences between the o-h stretching frequencies infrared spectra of the m-cresols in carbon tetrachloride soln & in the pure liq state. the binding of m-cresols apparently incr with their steric hindrance, & the binding depends on the partition between an aq phase & org phase.

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

Product

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is
