SECTION 4: First-aid measures

4.1 Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

4.2 Most important symptoms/effects, acute and delayed

Liver damage, metabolic stimulant, dermatitis, dilation of pupils. (USCG, 1999)

4.3 Indication of immediate medical attention and special treatment needed, if necessary

Basic treatment: Establish a patent airway. Suction if necessary. Watch for signs of respiratory insufficiency and assist ventilations if necessary. Administer oxygen by nonrebreather mask at 10 to 15 L/min. Monitor for shock and treat if necessary. Monitor for pulmonary edema and treat if necessary. Anticipate seizures and treat if necessary. For eye contamination, flush eyes if immediately with water. Irrigate each eye continuously with normal saline during transport. Do not use emetics. For ingestion, rinse mouth and administer 5 mL/kg up to 200 mL of water for dilution if the patient can swallow, has a strong gag reflex, and does not drool. Administer activated charcoal. Cover skin burns with dry sterile dressings after decontamination. Rapid body cooling may be necessary in case of hyperthermia. Salicylates are contraindicated. Dinitrophenol and related compounds

SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

6.2 Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

6.3 Methods and materials for containment and cleaning up

Spillages of pesticides at any stage of their storage or handling should be treated with great care. Liquid formulations may be reduced to solid phase by evaporation. Dry sweeping of solids is always hazardous: these should be removed by vacuum cleaning, or by dissolving them in water, or other solvent in the factory environment. Pesticides

10.3 Possibility of hazardous reactions

Fire hazard.Reacts with oxidizing materials and combustibles (USCG, 1999). Special Hazards of Combustion Products: Can detonate or explode when heated under confinement (USCG, 1999). Aromatic nitro compounds, such as 2-CYCLOHEXYL-4,6-DINITROPHENOL, range from slight to strong oxidizing agents. If mixed with reducing agents, including hydrides, sulfides and nitrides, they may begin a vigorous reaction that culminates in a detonation. The aromatic nitro compounds may explode in the presence of a base such as sodium hydroxide or potassium hydroxide even in the presence of water or organic solvents. The explosive tendencies of aromatic nitro compounds are increased by the presence of multiple nitro groups. Phenols do not behave as organic alcohols, as one might guess from the presence of a hydroxyl (-OH) group in their structure. Instead, they react as weak organic acids. Phenols and cresols are much weaker acids than common carboxylic acids (phenol has $pK_a = 9.88$). These materials are incompatible with strong reducing substances such as hydrides, nitrides, alkali metals, and sulfides. Flammable gas (H₂) is often generated, and the heat of the reaction may ignite the gas. Heat is also generated by the acid-base reaction between phenols and bases.

12.2 Persistence and degradability

An unidentified *Coccobacillus* isolated from a molluscicide test chamber containing *Australorbis glabratus* pr strain was capable of growing in medium containing 4,6-dinitro-2-cyclohexylphenol as the sole nitrogen source(1).

12.3 Bioaccumulative potential

An estimated BCF value of 800 was calculated for 2,4-dinitro-6-cyclohexylphenol (SRC), using a log Kow of 4.12(1) and a recommended regression-derived equation(2). According to a classification scheme(3), this BCF value suggests that bioconcentration in aquatic organisms is high.

12.4 Mobility in soil

The Koc of 2,4-dinitro-6-cyclohexylphenol is estimated as approximately 4,150(SRC), from its log Kow of 4.12(1) and a regression derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that 2,4-dinitro-6-cyclohexylphenol is expected to have slight mobility in soil. However, the pKa of 2,4-dinitro-6-cyclohexylphenol is 4.52(4), which indicates that this compound will exist primarily as an anion in moist soil surfaces and anions are expected to have very high mobility in soils than the neutral species(SRC).

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
