SECTION 4: First-aid measures

4.1 Description of necessary first-aid measures

If inhaled

Fresh air, rest. Half-upright position. Refer for medical attention. See Notes.

Following skin contact

Remove contaminated clothes. Rinse skin with plenty of water or shower. Refer for medical attention . See Notes.

Following eye contact

First rinse with plenty of water for several minutes (remove contact lenses if easily possible), then refer for medical attention.

Following ingestion

Rinse mouth. Give a slurry of activated charcoal in water to drink. Rest. Refer for medical attention .

4.2 Most important symptoms/effects, acute and delayed

This material is harmful or fatal if swallowed, inhaled, or absorbed through the skin. (EPA, 1998)

4.3 Indication of immediate medical attention and special treatment needed, if necessary

Airway protection. Ensure that a clear airway exists. Intubate the patients and aspirate the secretions with a large-bore suction device if necessary. Administer oxygen by mechanically assisted pulmonary ventilation if respiration is depressed. Improve tissue oxygenation as much as possible before administering atropine, so as to minimize the risk of ventricular fibrillation. In severe poisonings, it may be necessary to support pulmonary ventilation mechanically for several days. Organophosphate pesticides

SECTION 5: Fire-fighting measures

5.1 Suitable extinguishing media

If material on fire or involved in fire: Do not extinguish fire unless flow can be stopped. Use water in flooding quantities as fog. Solid streams of water may be ineffective. Cool all affected containers with flooding quantities of water. Apply water from as far a distance as possible. Use "alcohol" foam, dry chemical or carbon dioxide. 5.2 Specific hazards arising from the chemical

Non-Specific -- Organophosphorus Pesticide, n.o.s.) Container may explode in heat of fire. Fire and runoff from fire control water may produce irritating or poisonous gases. (Non-Specific -- Phosphoramidothioic Acid, O-Ethyl S-Methyl Ester) Emits very toxic fumes of nitrogen oxides, phosphorus oxides, and sulfur oxides when heated to decomposition. Stable at neutral pH. Avoid strong acids or alkalis. (EPA, 1998)

SECTION 10: Stability and reactivity

10.1 Reactivity

Decomposes on heating and on burning. This produces toxic and irritating fumes including nitrogen oxides, phosphorus oxides and sulfur oxides. Attacks mild steel and copper-containing alloys (technical grade).

10.2 Chemical stability

Stable at ambient temp.

10.3 Possibility of hazardous reactions

Organophosphates, such as METHAMIDOPHOS, are susceptible to formation of highly toxic and flammable phosphine gas in the presence of strong reducing agents such as hydrides. Partial oxidation by oxidizing agents may result in the release of toxic phosphorus oxides. Avoid strong acids or alkalis. [EPA, 1998].

12.1 Toxicity

- Toxicity to fish: LC50 Rainbow trout 25 ppm/96 hr, static

12.2 Persistence and degradability

AEROBIC: Half-lives in Mooretown, NJ loam, Florida sandy loam, and sandy loam were 0.583, 4.8, and 6.1 days under aerobic conditions(1).

12.3 Bioaccumulative potential

An estimated BCF of 3.1 was calculated for methamidophos(SRC), using a log Kow of -0.8(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

12.4 Mobility in soil

A Koc of 5 has been reported for methamidophos(1). According to a classification scheme(2), this Koc value suggests that methamidophos is expected to have very high mobility in soil.

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
