SECTION 4: First-aid measures

4.1 Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

4.2 Most important symptoms/effects, acute and delayed

Excerpt from ERG Guide 171 [Substances (Low to Moderate Hazard)]: Inhalation of material may be harmful. Contact may cause burns to skin and eyes. Inhalation of Asbestos dust may have a damaging effect on the lungs. Fire may produce irritating, corrosive and/or toxic gases. Some liquids produce vapors that may cause dizziness or suffocation. Runoff from fire control may cause pollution. (ERG, 2016)

4.3 Indication of immediate medical attention and special treatment needed, if necessary

A comatose patient who is diaphoretic, has pinpoint pupils and the odor of an insecticide on clothing or breath, and is noted to have muscle fasciculations represents the classic presentation of organophosphate poisoning. ... Specific steps in management include the following. 1. Decontamination. ... 2 Airway. Establish an airway if necessary. ... 3. Respiratory Status. Respiratory distress, in fact, is commonly found in these patients from multiple causes. ... 4. Cardiac Monitoring. ... 5. Cholinesterase Level. ... 6. Pralidoxime. Pralidoxime is the treatment of choice for organophosphate poisoning and should be used for nearly all patients with clinically significant organophosphate poisoning, particularly those patients with muscular fasciculations and weakness. ... 7. Atropine. Atropine is the physiologic antidote for organophosphate poisoning. A trial dose of atropine should be instituted on clinical ground when one suspects organophosphate intoxication. SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

6.2 Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

Organophosphates, such as ISODECYL DIPHENYL PHOSPHATE, are susceptible to formation of highly toxic and flammable phosphine gas in the presence of strong reducing agents such as hydrides. Partial oxidation by oxidizing agents may result in the release of toxic phosphorus oxides.

SECTION 12: Ecological information

12.1 Toxicity

- Toxicity to fish: LC50 *Lepomis macrochirus* 6700 ppm/96 hr, static bioassay in fresh water at 23 deg C, mild aeration applied after 24 hr.
- Toxicity to daphnia and other aquatic invertebrates: no data available

12.2 Persistence and degradability

The ultimate biodegradation of isodecyl diphenyl phosphate, initial concn of 19 ppm, was observed to be 13.5, 63.3, and 68.4% of theoretical CO₂ evolution in a CO₂-evolution screening study using acclimated seed (14 day acclimation period) over an incubation period of 7, 28, and 35 days, respectively. Isodecyl diphenyl phosphate biodegraded 20 to 54% with an addition rate of 13 to 3 1/ppm-hr, respectively, in semicontinuous activated sludge (SCAS) tests and a half-life of about 11 days was observed in a river die-away test for isodecyl diphenyl phosphate at an initial concn of 1 ppm(1).

12.3 Bioaccumulative potential

Calculated BCFs of 1,100(1) and 7,500(2) indicate that isodecyl diphenyl phosphate has a moderate potential to bioconcentrate in aquatic organisms(1, SRC).

12.4 Mobility in soil

Based upon a measured log K_{ow} of 5.44(1), the K_{oc} for isodecyl diphenyl phosphate can be estimated to be about 21,695 from a regression derived equation(2). According to a suggested classification scheme(3), isodecyl diphenyl phosphate should be immobile in soil and sediment. The low water solubility of 0.75 mg/l at 25 deg C(1) and high K_{oc} value suggest that adsorption to soil and sediment may be an important fate process for isodecyl diphenyl phosphate(4, SRC).

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
