4.1 Description of necessary first-aid measures

If inhaled

Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

SECTION 12: Ecological information

12.1 Toxicity

- Toxicity to fish: LC50 - *Oryzias latipes* - > 5 mg/L - 96 h.
- Toxicity to daphnia and other aquatic invertebrates: EC50 - *Daphnia magna* - > 4.8 mg/L - 48 h.
- Toxicity to algae: EC50 - *Pseudokirchneriella subcapitata* (previous names: *Raphidocelis subcapitata*, *Selenastrum capricornutum*) - > 5 mg/L - 72 h.
- Toxicity to microorganisms: EC50 - activated sludge - > 10 000 mg/L - 3 h. Remarks: Respiration rate.

12.2 Persistence and degradability

A four week biodegradation study using 30 mg/l sludge and a bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane concentration of 100 mg/L gave a 0% theoretical BOD(1).

12.3 Bioaccumulative potential

An estimated BCF value of 33100 was calculated for bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane(SRC), using an experimental log Kow of 6.25(1) and a recommended regression-derived equation(2). Bioconcentration factors of 23-37 and 60-125 were obtained during an 8 week bioconcentration study using carp and bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane concentrations of 1 and 0.1 mg/l, respectively(1). According to a recommended classification scheme(3), the experimental BCF values suggest that bioconcentration in aquatic organisms will be moderate to high(SRC).

12.4 Mobility in soil

The Koc of bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane is estimated as approximately 59800(SRC), using an experimental log Kow of 6.25(1) and a regression-derived equation(2, SRC). According to a recommended classification scheme(3), this estimated Koc value suggests that bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane will be immobile in soil and strongly adsorbed to suspended solids and sediment in water(SRC).

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
