4.1 Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Absorption, Distribution and Excretion

Rats readily excreted (14)C EHT given in a single dose at 100 mg/kg. 57.9%, 28.6%, and 3.6% of the (14)C was recovered in the feces, urine an expired air, respectively, within 144 hr after admin. Only 2.1% remained in the carcass.

6.1 Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

6.2 Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

6.3 Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

SECTION 12: Ecological information

12.1 Toxicity

- Toxicity to fish: LC50 - *Oncorhynchus mykiss* (previous name: *Salmo gairdneri*) - > 0.25 mg/L - 7 d.
- Toxicity to daphnia and other aquatic invertebrates: EC50 - *Daphnia magna* - > 1.4 µg/L - 48 h.
- Toxicity to algae: EC50 - *Pseudokirchneriella subcapitata* (previous names: *Raphidocelis subcapitata*, *Selenastrum capricornutum*) - > 0.86 mg/L - 72 h.
- Toxicity to microorganisms: EC50 - activated sludge of a predominantly domestic sewage - > 10 mg/L - 3 h. Remarks: Respiration rate.

12.2 Persistence and degradability

Biodegradation data on bis(2-ethylhexyl) terephthalate were not available (SRC, 2008); however, bis(2-ethylhexyl) phthalate, a structurally similar compound, is reported to undergo aerobic (1,2) and possibly anaerobic biodegradation (3,4). Therefore, biodegradation is likely to be an important fate process for bis(2-ethylhexyl) terephthalate.

12.3 Bioaccumulative potential

An estimated BCF of 25 was calculated in fish for bis(2-ethylhexyl) terephthalate (SRC), using an estimated log K_{ow} of 8.39 (1) and a regression-derived equation (2). According to a classification scheme (3), this BCF suggests the potential for bioconcentration in aquatic organisms is low (SRC).

12.4 Mobility in soil

The K_{oc} of bis(2-ethylhexyl) terephthalate is estimated as 2,000 (SRC), using a water solubility of 4 mg/L (1) and a regression-derived equation (2). According to a classification scheme (3), this estimated K_{oc} value suggests that bis(2-ethylhexyl) terephthalate is expected to have slight mobility in soil.

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
