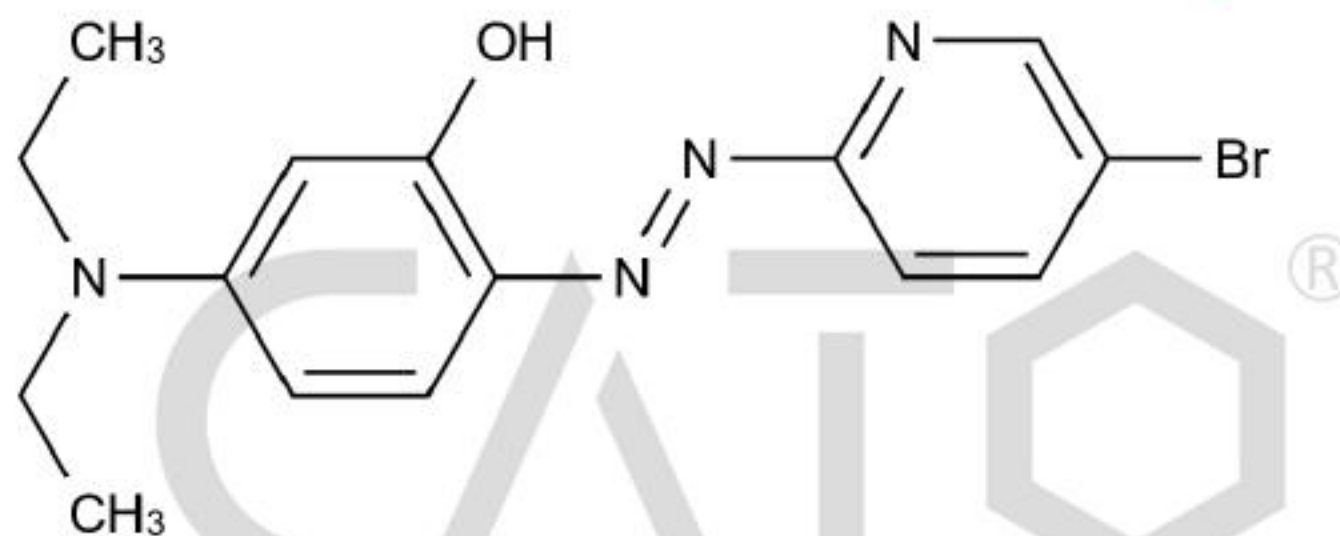

A normal distribution is assumed and a coverage factor of K=2 is chosen using approximately a 95% confidence level.
