If inhaled

6.1 Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

12.2 Persistence and degradability

AEROBIC: Polybrominated biphenyls such as decabromobiphenyl are known to be persistent in the environment under aerobic conditions(3). Decabromobiphenyl at 100 mg/L achieved 0.8% of its theoretical BOD using 30 mg/L of activated sludge over a 2 week incubation period using the Japanese MITI test(1). In a second screening test, decabromobiphenyl, present at 100 mg/L, reached 0-29% of its theoretical BOD in 2 weeks using an activated sludge inoculum at 30 mg/L(2).

12.3 Bioaccumulative potential

A BCF range of 0.6-5.4 was measured for carp exposed to 0.15 mg/L of decabromobiphenyl over a 6 week incubation period and a BCF of <4 was measured for carp exposed to 0.015 mg/L over a 6 week incubation period(1) According to a classification scheme(2), these BCF values suggests bioconcentration in aquatic organisms is low(SRC).

12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc for decabromobiphenyl can be estimated to be 994,000(SRC). According to a classification scheme(2), this estimated Koc value suggests that decabromobiphenyl is expected to be immobile in soil(SRC).

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
